Important information

Some types of goods and types of parcels can not be transported!

Examples of items that are excluded from GLS network transport:

- Parcels insufficiently packaged or with nonstandard packaging
- Precious goods (e.g. money, noble metals, securities, jewellery, precious stones, antiques)
- Goods with value over CZK 20 000
- Food, perishable goods, bad smelling and infectious goods
- Temperature-sensitive goods
- Goods requiring any special treatment (e.g. shipment in a certain position, fragile)
- Ammunition, firearms, explosives
- Items whose sending is prohibited by any applicable law

How to calculate the parcel size

Dimensional category = sum of the shortest side and the longest side

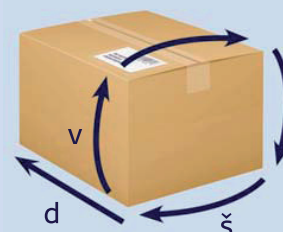
Maximum circumference length 300 cm (1x length + 2x width + 2x height)

Maximum height 60 cm

Maximum width 80 cm

Maximum length when shipped from PS 100 cm

Maximum weight when shipped from PS 15 kg, when picked up by the courier 40 kg



Notice:

- GLS works solely on the basis of the currently applicable Business Conditions which can be downloaded at www.e-balik.cz.
- Shipments are excluded to countries outside the European Union and to all destinations which are subject to the customs procedure, including shipments within the European Union to the following destinations: Andorra, Ceuta, Gibraltar, Greece, Livigno, Malta, Melilla, San Marino, Cyprus, the city of Büsingen am Hochrhein (postal code D-78266), overseas territories and all European islands, except Ireland and islands belonging to Germany and Croatia.
- Sending to a PO Box address is not possible.
- The goods must be sufficiently packed and fit for bulk parcel transport.
- If a parcel accepted for shipment cannot be delivered for any of the above reasons, GLS will transport the parcel back to the sender. The freight charge paid is not refunded in this case.

Pricing conditions for drawing discounts via an e-Balik credit system

Definition

The User of the credit system may be an entity that is registered as an **e-Balik** user and a business entity with a valid Company ID at the same time.

Credit is the sum of User's funds within the **e-Balik** application, provided to GLS by the User to pay the price of forwarding services provided in the future, and which serves as a mean of payment of the **e-Balik** application environment.

Discount rules

The discount system follows a simple rule:

„The more parcels you send, the less you pay for a parcel!“

Monthly drawing of credits:	Returned credits:
500 – 999	10
1.000 – 1.999	50
2.000 – 4.999	150
5.000 – 7.999	500
8.000 – 9.999	1.000
10.000 and more	1.300

Discount system is conditional for the use of payment by credits. Both, direct Online payment and cash payment do not count towards your monthly volume.

Example of discount calculation

A company that sends national parcels via GLS with an average weight of 3 kg (dimension S) and can generate 65 parcels sent per month. The company uses GLS ParcelShop for dispatch of parcels. The company does not use additional GLS services.

Monthly drawing credits: 6 045

Returned credits: 500

Real credit usage: 5 545

Original average price per parcel: 93 CZK including VAT and surcharges

New average price per parcel using the credit system: 85.3 CZK including VAT and surcharges

Percentage saving: 8.3 %
